A « laboratoire d'excellence »

The Laboratory for interdisciplinary evaluation of public policies (LIEPP) is an "excellence laboratory" (Labex), a title it has been granted by an international scientific jury appointed by the French National Research Agency (ANR). It is financed for ten years, within the framework of the "Investissements d'avenir", a national program of investment in promising research projects (ANR-11-LABX-0091 & ANR-11-IDEX-0005-02).

A multidisciplinary team

LIEPP adopts an innovative approach, based on interdisciplinary discussions and a combination of qualitative, quantitative and comparative evaluations of the same policy object. The laboratory brings together more than 180 researchers, most of them coming from Sciences Po, and promotes dialogue between economists, sociologists, political scientists, laywers and historians. While LIEPP is institutionally based within Sciences Po, researchers from other French and international universities collaborate to the evaluation projects. The work also relies on international scientific cooperation networks developed by the LIEPP's research founding units.

Publications

One of LIEPP's missions is to disseminate and make publicly available its research findings in order to improve public policies.

Working Paper: Written by one or more researchers from an ongoing project, working paper aims to stimulate scientific discussions and to contribute to a better understanding of the topic.

Policy Brief: An argued and concise publication, accessible beyond the academic audience, presenting results of a research project as well as recommandations for policy makers.

Débats du LIEPP: An overview of the different scientific positions on a public policy evaluation question, including politicians' reactions to the scientific public policy controversy.

LIEPP Report: Reports focusing on specific policy evaluations.
