The word of the Director

2025 was a landmark year for the CEE, marked by exceptional research output and vibrant academic exchange. Our community produced 12 books, 54 peer-reviewed articles, and 20 book chapters, a testament to our dedication to advancing knowledge. These achievements were made possible by our active participation in national and international research networks, as well as enduring partnerships supported by prestigious external funding—including 2 ERC grants, 4 Horizon Europe, and 3 ANR projects.

CEE members showcased their work at leading congresses and conferences, such as AFSP, AFS, APSA, CES, ECPR, EPSA, IPPA, IPSA, and SASE, and at workshops and seminars across Europe and beyond. Committed to sustainability, many of us embraced train travel, turning long journeys into productive moments for reading, discussion, reflection, and writing.

As a hub for intellectual exchange and thanks to our dynamic support team, the CEE hosted 90 scientific events, including 14 workshops and conferences, and welcomed six long-term visiting faculty and 23 short-term scholars. Our outreach extended to policymakers at all levels—from local and regional authorities to national legislators and departments and EU institutions—ensuring our research informs public debate and policy. We also engaged with civil society through media interviews, school talks, and collaborations with professional organizations and trade unions.

Inclusion and diversity remained central to our mission. We organized five workshops focused on supporting early career researchers, fostering professionalization, and building confidence, while nurturing a warm, bilingual research culture. With 11 nationalities among our 32 permanent faculty and many more represented in our 92-strong community—including 44 PhD researchers—our halls buzz with a rich diversity of languages and ideas.

Here's to another year of groundbreaking research, vibrant community, and meaningful impact in public debates!

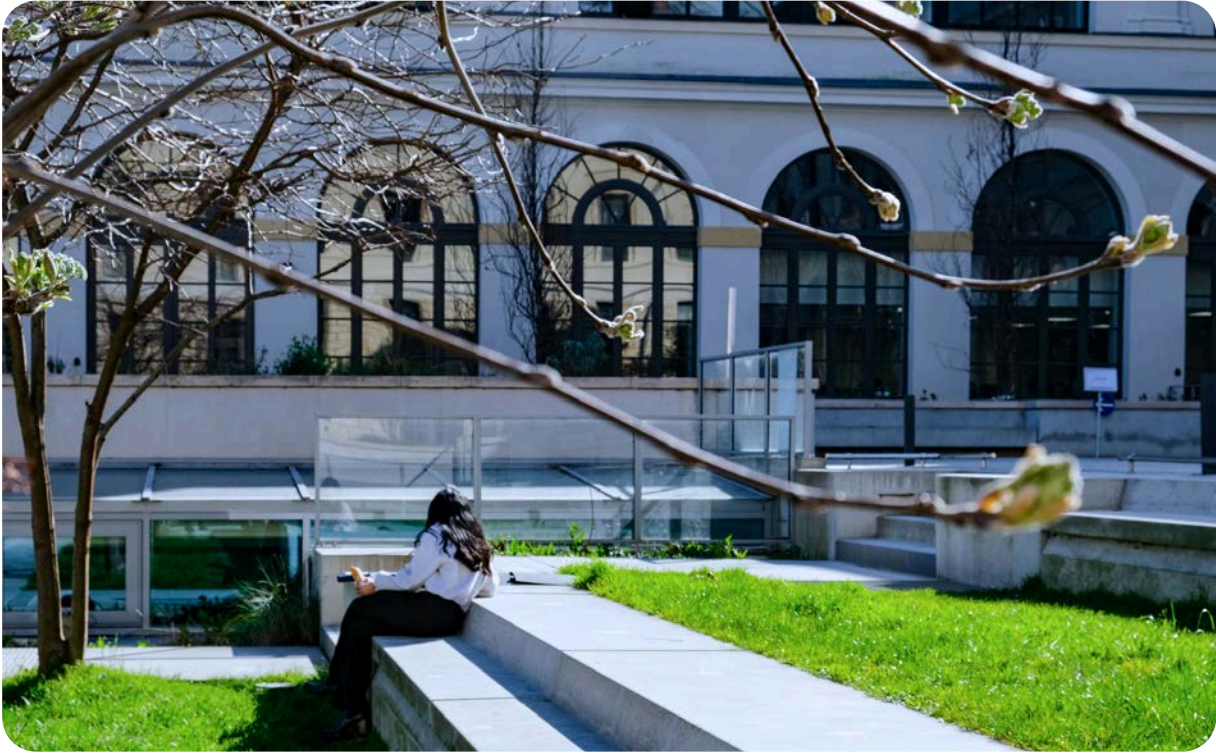

GROWTH OF THE PERMANENT FACULTY

The year 2025 marks a significant milestone in the CEE's development, with the integration of three new members into our permanent faculty, further enriching our scientific expertise on European issues.



Diane Bolet joins the CEE as Assistant Professor. Her research explores the intersection of politics and policy with territory in European countries. As the recipient of a prestigious ERC Starting Grant, she will lead a major research project from 2026 to 2031 examining the impact of European Union climate policies on fossil-fuel-dependent communities. This comparative study, covering France, Germany, the United Kingdom and Poland, provides crucial insights into socio-economic transitions within the mining, gas and agricultural sectors.



Tom Chevalier, a CNRS Junior Professor, analyses youth-focused public policy in Europe. A specialist in welfare policies, education and employment, he brings both academic and institutional expertise, sitting on the Scientific Committee of the National Council for Policies to Combat Poverty and Social Exclusion (CNLE) and represents France within the European Commission's European Social Policy Analysis Network (ESPAN). His second research focus lies in how the welfare state adapts to climate change.



Paula Hoffmeyer-Zlotnik, Assistant Professor, is a specialist of European migratory policies and politics. Her research examines how political dynamics influence policy design and implementation, with a particular focus on the role of the European Commission. Current work explores less politicized forms of immigration while analyzing the discursive strategies and narratives used by political actors to shape the politicisation process.

INTERNATIONAL RESEARCH MOBILITY

The CEE's dynamism is further evidenced in 2025 by the arrival of 1-year invited researchers, strengthening our ties with leading partner institutions.

The laboratory welcomed **Marylou Hamm**, a CIVICA post-doctoral researcher from the European University Institute (EUI). A political sociologist, her work explores European policy-making processes, focusing on crisis management and administrative reform.

Anja Röcke joined us as the Alfred Grosser Chair, supported by the Fritz Thyssen Foundation. Her current research investigates a binational citizens' council within the Sarre-Moselle Eurodistrict, contributing to the CEE's ongoing reflections on new forms of democratic participation.

A NEW GENERATION OF DOCTORAL RESEARCHERS

In 2025, the CEE welcomed seven new PhD candidates.

Awards and Honours



William Genieys has received a double accolade, winning both the 2025 Louis Brownlow Book Award and the IPPA Book Prize for his publication *A Government of Insiders: The People Who Made the Affordable Care Act Possible* (Johns Hopkins University Press, 2024). His research highlights the decisive role played by a group of non-elected government elites in shaping one of the most significant reforms in the history of the American healthcare system.

Charlotte Halpern has been recognized in Innovapresse's *100 qui font la ville* (100 Who Make the City) awards, which annually honours the most dedicated figures driving urban and regional transformation. This recognition reflects the impact of her research on urban governance and the challenges cities face in adapting to contemporary shifts.

Pietro Castelli Gattinara and **Caterina Froio** were awarded the ULB Scientific Outreach Award by l'*Université libre de Bruxelles* for their work on the FARPO (Far-Right Protest Observatory) project platform. The result of rigorous collective effort, this platform provides both the scientific community and the general public with structured data on far-right mobilizations across Europe over the last twenty years, documenting the locations, dates, actors and motivations of every recorded event.

THESES DEFENDED

Lennard Alke defended his PhD thesis on May 15th, 2025 - "To debate or not to debate: politicization dynamics of EU affairs in national parliaments", supervised by Emiliano Grossman.

Jan Boguslawski defended his PhD thesis on June 23rd, 2025 - "(De)financializing the welfare state. Evidence from Poland", supervised by Bruno Palier.

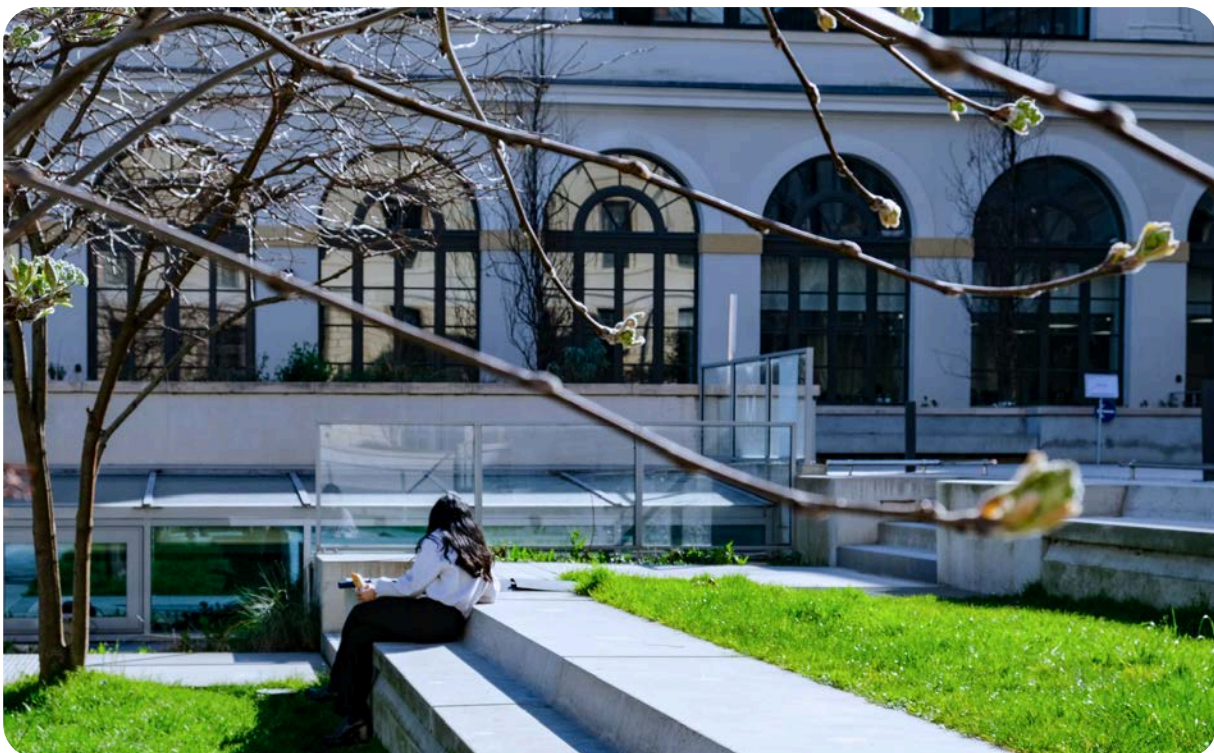
Research In Progress

Research at the CEE is organized into four key areas:

- **State and public policies** (led by **Philippe Bezes**, **Charlotte Halpern** and **Ulrike Lepont**) - focuses on transformations in public policymaking and the processes of state restructuring.
- **Strains on democratic representation** (led by **Saga Oskarson Kindstrand** and **Jan Rovny**) - explores the roots, drivers and consequences of contemporary political dynamics in terms of political representation, participation and competition.
- **Transformations of capitalism** (led by **Zsófia Barta**, **Cyril Benoît** and **Matthias Thiemann**) - studies the processes of capitalist transformation through the internationalization, tertiarization and financialization of economies, as well as their political effects.
- **Cities, borders, mobilities** (led by **Gabriel Feltran** and **Virginie Guiraudon**) - examines the consequences of rising inequality, environmental transformations and the circulation of people, capital, objects, viruses, information, technologies and ideas.

Nevertheless, we present them here thematically to highlight how our approaches consistently analyse societal dynamics, politics and policy. These themes are addressed using **comparative methods** that place **Europe** in perspective within its neighbourhood and the wider world.

Note: Some projects involve partners from outside the CEE; however, due to space constraints, they are not always listed.



INSTITUTIONS, REPRESENTATION AND DEMOCRATIC RESILIENCE IN EUROPE

Researchers at the CEE continue to examine issues of party competition, political socialization, participation, representation and trust. Within the broader context of the challenge to liberal democracy, other projects explore the rise of far-right movements, illiberal trends and the legacies of autocracies in Europe.

POLITICAL PARTIES AND PARTY COMPETITION

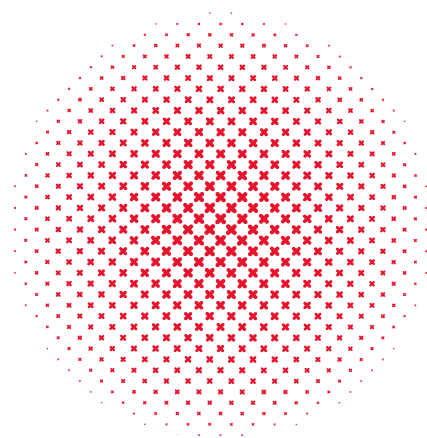
This year, **Florence Haegel**, with Carole Bachelot and Alexandre Dézé, published *Introduction à la sociologie des partis politiques* (*An Introduction to the Sociology of Political Parties*). Her research focuses on the formation of right-wing coalitions in France and Chile, specifically the growing alignment between the mainstream right and the far-right. She also continues to work on the organizational consequences of the decline of traditional parties. This is a subject also explored by **Saga Oskarson Kindstrand** in her thesis: by comparing the Swedish Social Democrats and the (radical right) Sweden Democrats, she aims to understand how populist parties manage to bridge the widening gap between traditional parties and a base they are struggling to mobilize.

Following on from their research into tunnels of attention, the tendency for parties to converge on the same themes during election campaigns, **Emiliano Grossman** and **Isabelle Guinaudeau** (associate researcher) are now focused on understanding how new issues emerge during a campaign.

Lennard Alke's recently defended thesis examined the politicization of EU affairs in plenary speeches delivered in the national parliaments of France, Germany and the UK.

Finally, within the context of their doctoral research, **Malo Jan** and **Luis Sattelmayer** have established the PartySOME database, a comprehensive record of the social media output of approximately 500 political parties across 37 European countries.

Luis Sattelmayer's thesis draws on this data to study how traditional parties position themselves on salient far-right issues such as immigration, and how it contributes to mainstream parties' decline.



POLITICAL SOCIALIZATION, PARTICIPATION AND REPRESENTATION

What are the effects of generational renewal? **Colin Hay** continues to research political socialization across generations, taking into account the impact of Brexit and Covid-19 on political socialization in the United Kingdom. **Chiao Li**'s doctoral research focuses on the transformation of electoral participation and party preferences across generations in Western Europe.

Other research examines the practices of elected representatives. **Florence Haegel** has launched a collective comparative project on presidential practice in Europe and beyond. **Ronja Sczepanski** focuses on the representation of different social groups within European institutions and the way in which MEPs interpret their role as representatives.

Isabelle Guinaudeau (PI), **Emiliano Grossman** and **Selma Sarenkapa** study the differential treatment of various social groups in electoral pledges and their subsequent fulfilment in Germany and France (UNEQUALMAND, ANR-DFG, 2022-26), and how the sense of being represented is affected as a result. To this end, they employ computational methods and experimental surveys. The thesis of **Selma Sarenkapa** focuses specifically on the treatment of approximately one hundred target groups in the media of both countries. By comparing some thirty countries using machine learning, **Emiliano Grossman** and **Isabelle Guinaudeau** also explore the circumstances in which majority governments may not feel constrained by their electoral mandate, and whether this poses a risk of democratic backsliding.

LIBERAL DEMOCRACY CONTESTED

With the participation of **Jan Rovny** (PI), **Caterina Froio**, **Elena Cossu** and **Luis Sattelmayer**, the European project AUTHLIB (Horizon Europe, 2022-26) has sought to map liberal representative systems in Europe that are under threat from various types of ideologies. The team analyzed the project's data (including surveys such as CHES Europe, documents, etc) to provide an overview of the current state of support for democracy among political parties and citizens in France. **Caterina Froio** and **Elena Cossu** utilized the tweets collected as part of the project to study the evolution of party discourse on cultural diversity, immigration and Islam in France, following the 2015–2016 terrorist attacks. **Jan Rovny**, alongside other colleagues, assessed the findings of an experimental survey conducted in seven countries, showing the conditions under which democratic backsliding is accepted by citizens.

In addition, **Jan Rovny** is also working with **Filip Kostelka** (associate researcher) on the presidential elections in Europe, particularly the conditions under which voters and unsuccessful candidates shift their support to illiberal candidates.

Catarina Leão (currently associate researcher) was funded by AxPo to study the extent to which autocratic legacies in European democracies can influence the propensity for social mobilization and preferences regarding economic policy. In particular, she is working with **Jan Rovny** on the consequences of communist indoctrination.

POLITICAL SOCIALIZATION, PARTICIPATION AND REPRESENTATION

In an edited volume forthcoming from Oxford University Press, **Caterina Froio** examines the conditions and mechanisms through which far-right protests bolster far-right institutional politics.

Paula Hoffmeyer-Zlotnik contributes to a comparative study across six European countries examining support for the cordon sanitaire against the far right.

European radical-right parties are also the subject of several theses. **María-Katrina Cortez** examines political shifts towards the right and the radical right, the resurgence of Catholicism as a political force, and religious conversions driven by identity-based and political motives in France. **Marius Perrin** researches the normalization of the far right in Europe, based on the cases of Sweden, Norway and France. **Noémie Piolat** investigates gendered attitudes and their political consequences, with a particular focus on the links between sexism and support for radical-right parties in Europe. **Alberto Polimeni** examines how the rhetoric and discourse of far-right populist parties influence the policy agendas, framing and vocabulary of mainstream parties.

Pierre Charbonnier is exploring the revival of technocratic thought, examining the role of technological thinking in politics, particularly in the United States and China. He analyses models of society where decision-making is entrusted to experts, presenting alternatives to liberal democracy.

Philippe Bezes studies, with **Émilien Houard-Vial** (associate researcher), the effects of populism on the French public administration.

Certain technical mechanisms also have implications for democracy. **Marco Cremaschi** studies the links between specific forms of urban planning and the undermining of democracy. **Dominique Boullier** examines the links between digital technology and democracy. In particular, he studies the challenges posed by the design of certain artificial intelligence (AI) systems and digital platform architecture, as well as disinformation patterns. In this context, he organised an interdisciplinary symposium entitled "Propagation: A New Paradigm for the Social Sciences" with the support of the centre.

The Age of backlashes – a collective project

A series of reactions against environmental movements and environmental policies; feminist and queer movements; gender equality policies and diversity policies; recognition and integration of minorities; democratization and democratic politics – including democratic backsliding – are currently occurring simultaneously and involve similar groups and parties. This project, coordinated by **Bruno Palier**, **Noémie Piolat** and **Lucien Thabourey** seeks to understand the drivers behind these concurrent similarities. The idea came from the observation that several CEE members work on these processes across different fields (environmental policies, democracy or feminist movements, etc) and with varied approaches.

DEMOCRATIC RESILIENCE

Contrary to narratives regarding public disillusionment with democracy, the volume *French Democracy in Distress*, co-edited by, among others, **Nonna Mayer** and **Elodie Druetz** (associate researcher), offers an alternative diagnosis. The issue stems instead from the gap between high democratic aspirations and a perceived dissatisfaction with the functioning of democracy.

Emiliano Grossman and **Isabelle Guinaudeau** contributed a chapter demonstrating that fulfilling election pledges yields little political reward. **Nonna Mayer** is co-author of chapters on the impact of generational turnover on far-right voting patterns (with **Elodie Druetz** and **Mickael Durand**, associate researchers) and on the links between social and political exclusion.

Could citizen assemblies be part of the solution? In her thesis, **Jessica De Rongé** examines the levels of trust that both citizens and politicians place in "mini-publics" – citizens' assemblies representative of the general population and formed through random selection. Their goal is to allow participants to educate themselves and deliberate on a specific topic, ultimately informing public opinion and the decision-making process. This thesis is being carried out as part of the ERC-funded project POLLOT - Political Lotteries in European Democratisation led by **Brenda Van Copenolle**



THE POLITICAL IMPACTS OF ECONOMIC AND SOCIAL INEQUALITY

Several research projects at the CEE examine economic and social inequalities as well as their political consequences, notably through the study of voting behaviour in a context of widening inequality and social polarization.

Bruno Cousin is a member of the “method committee” of the [World Elite Database](#), a comparative research consortium focusing on economic elites in Europe, the Americas and Asia. [The article](#) describing the database, published in early 2025, rapidly achieved the highest media coverage in the history of the *British Journal of Sociology*, and the consortium now covers 22 countries (up from 16 previously). Furthermore, **Bruno Cousin** collaborates with **Tommaso Vitale** on a project on spatial segregation in Rome, Milan and Naples (ROMINA).

Anja Durovic (associate researcher), **Nonna Mayer** and **Noémie Piolat** evaluated the impact of gender and sexism on voting behaviour during the 2024 [European](#) and [legislative](#) elections in France. Their findings show that women now vote as much as (or even more than) men for the *Rassemblement national* (National Rally or RN); more than gender itself, sexist attitudes (in the broad sense) constituted a key explanatory factor in electoral choices.

Working with European colleagues, **Colin Hay** is studying the impact of wealth inequality on voting behaviour, specifically on support for the populist right. Having previously examined the case of support for Trump, they now intend to extend this study to various European countries.

Together with **Paulus Wagner** (associate researcher), **Bruno Palier** is exploring the political consequences of poor working conditions and poor management, particularly in terms of far-right voting. The thesis of **Charlotte Boucher** studies how labour market and welfare reforms have affected European political systems, particularly regarding perceptions of social integration and the rise in support for radical-right parties. **Jens Castens'** [recently defended thesis](#) demonstrates that when citizens perceive the place they live in as neglected or in decline, their trust in institutions erodes. This erosion often transforms healthy scepticism into cynical distrust, which alienates citizens from institutions and makes them more receptive to far-right rhetoric.

DIVERSE SOCIETIES: MIGRATION, MINORITIES AND INCLUSION IN EUROPE

SOCIAL INEQUALITY

Several research projects conducted at the CEE focus on minorities, their political participation and inclusion within institutions, as well as the discourse and attitudes towards them.

MIGRATION: BETWEEN DATA, POLICIES AND LIVED EXPERIENCES

Laura Morales coordinates the project OPENMIN (ANR, 2024-26) in which **Yuma Ando**, **Ekaterina Iakovleva** and **Dimitrios Rafail Tservenis** also participate. This project consolidates and expands a series of open science and open data initiatives to stimulate comparative research on minorities and migration in Europe. The team has contributed to the development of a medium- and long-term roadmap for the establishment of a European research infrastructure dedicated to migration studies.

The research of **Paula Hoffmeyer-Zlotnik** focuses on immigration policy in Europe and within the European Union, notably the evolution of the European Commission's positions on migration, including its discourse on return policy. She also studies the instrumentalization of the immigration issue – for example, in the context of the hybrid warfare waged by Russia.

As the European Union embarks on increasingly restrictive immigration policies, **Ronja Szczepanski** studies the consequences of European citizens' support for the Union, and demonstrates the resulting polarisation of public opinion.

Soazig Dollet is completing a thesis on the experiences of asylees in regarding the reception and integration systems designed for them, such as residential placements outside major urban areas and support from social workers.

In her thesis, **Anna Pereti** studies how housing policies, welfare regimes and urban governance traditions impact the local integration of migrants in four European cities: Paris, Marseille, Rome and Naples.

Marco Cremaschi and **Tommaso Vitale** also examined the reception and integration of asylum seekers in Paris, focusing on the governance of public spaces.

PREJUDICE AND DISCRIMINATION

Yuma Ando, **Nonna Mayer** and **Tommaso Vitale** participate annually in the CNCDH barometer, a survey aimed at evaluating racist and anti-Semitic perceptions and attitudes in France, and at analyzing the underlying logic behind the emergence and persistence of certain prejudices. The 2024 barometer (published in 2025) confirms a growing generational divide regarding levels of tolerance.

Tommaso Vitale also examines housing discrimination against the Roma across several European countries (including France, Italy and Spain), documenting how anti-Gypsyism and structural obstacles affect housing deprivation, the fluctuations in slum clearance policies and the barriers to upward social mobility.

Arno Lizet completed a project started during his master's thesis on anti-trans movements in Europe.

MINORITIES AND POLITICS

Laura Morales led the REPCANCE – Spain and the United Kingdom project (Robert Bosch Stiftung, 2022–25) aiming to better understand the obstacles faced by people from immigrant backgrounds seeking senior roles, particularly in politics. The final report also identifies initiatives that can help overcome these barriers.

Following on from his work on ethnic minorities in politics, **Jan Rovny** is focusing on the support for liberal democracy among religious minorities in Western Europe, with **Elena Cossu** and **Luis Sattelmayer**, as part of the AUTHLIB project (see above).

EUROPE IN THE ANTHROPOCENE

Environmental transformations are now affecting every dimension of European society and politics. At the CEE, these are studied from various angles, ranging from the history of ideas to territorial adaptation, as well as the polarization surrounding these issues and the role of public authorities.

TRACING THE HISTORY OF IDEAS TO ILLUMINATE CURRENT TRANSFORMATIONS

Thomas Kayzel, post-doctoral researcher funded by the Bruno Latour Fund (2023-26), analyzes the origins of the idea of limitless economic growth, which he traces back to a transformation in the conceptions of nature and progress in 19th-century economic thought. In addition, he is continuing his work on the history of planning.

Three theses drawing on the history of ideas are currently underway: **Marius Bickhardt's** work on the environmental history of the concept of overpopulation and pronatalist or anti-natalist doctrines, through to contemporary neo-Malthusianism. **Léo Grillet's** research seeks to evaluate the widely held hypothesis that militant and philosophical anarchism has often demonstrated foresight regarding the degradation of the natural environment. **Raphaël Gialdini** studies the history of insurance theories in the face of natural risks, from their inception in the 18th century to the recent crisis in environmental security regimes.

Pierre Charbonnier and **Thomas Kayzel** have also conducted in-depth research in philosophy and political theory on the methodology of the history of ideas.

ENVIRONMENTAL ACTIVISM

Joost de Moor studies several key aspects of climate activism in Europe through the Fridays for Future movement. Alongside Swedish colleagues, he has finalized a monograph to be published by De Gruyter, on visions of the future within the Swedish climate movement. He also addresses the link between the nature of environmental problems and the collective efforts to tackle them, illustrated by various European examples.

Lucien Thabourey's thesis seeks to understand how the relationship with the State is being transformed among movements and activists practicing civil disobedience in France and the United Kingdom. His thesis theorizes this relationship across four overlapping and interacting dimensions: sovereignty and territory, regulation and the welfare state, justice and coercion, and democracy and citizenship. **Maxime Gaborit** analyzes references to death in the discourse and practices of climate activists, proposing in his thesis a political theory in which politics is seen as a conflict between different forms of death. In her doctoral research, **Justine Banégas** studies the interactions between environmental mobilizations and judicial institutions in France and the UK. Through the study of trials, she aims to examine how anti-terrorism discourse and instruments are applied to these new forms of mobilization. In addition, she published an article based on her Master's thesis showing how the "anti-chlordecone" campaign has become a laboratory for legal mobilisations and the lessons it can teach about repairing and redressing.

A CONFLICTUAL TRANSITION

The works of **Pierre Charbonnier** (*La Coalition climat*, Seuil) and **Cyril Benoit** (*Growth, Democracy, or Climate Action? The New Trilemma of Advanced Capitalism*, Agenda publishing, with Aidan Regan, Hanna Schwander and Tim Vlandas, forthcoming 2026) place political conflicts and social coalitions at the heart of their political economy analyses of the climate transition.

These conflicts are characterized in several other research projects at the CEE, at the levels of individuals, parties, institutions and public policies, contributing to reflections on the just transition.

What are the links between the sense of identity loss, opposition to climate and environmental policies ("greenlash") and support for the far right in Europe? This is what **Diane Bolet** seeks to discover by studying the repercussions of these policies on communities dependent on fossil fuels (coal, oil and gas) or exposed to environmental regulations (for example, farmers) in France, Germany, the United Kingdom and Poland. She has just been awarded an ERC Starting Grant to organize this project.

Several theses are also examining the political consequences of the ecological transition. **Théodore Tallent** is studying the opposition to and support for the transition in rural areas. He shows, for example, that rural Europeans are neither less concerned about the climate nor opposed in principle to climate action; however, they are more likely to resist policies perceived as costly or ill-adapted. **Simon Audebert** examines the electoral consequences of attitudes towards ecology in rural territories differently affected by productivism and industrial development. **Paul Servais** has just started a thesis on the direct and indirect effects of climate change on political behaviour in Western Europe.

To understand the variations in support for climate policies, **Emiliano Grossman** has examined the evolution of anti-science attitudes in France, which can no longer be explained by traditional factors such as education level or religiosity. Working with Cristina Peñasco (Banque de France), he has shown that the link between recognizing the reality of climate change and support for climate policies is less robust in wealthy countries where this subject has become highly politicized.

Sophia Stutzmann (funded by AxPo) is focusing on retraining policies aimed at supporting people working in "brown" jobs to transition to "green" jobs. She seeks to uncover the determinants of preferences towards green-transition retraining policies among various stakeholders – affected workers, works councils and managers – across different industries and countries. Subsequently, she will examine how these preferences influence the policymaking process.

Matteo Mandelli (PI) and **Charlotte Halpern** are funded by the Open Society Hub for Politics of the Anthropocene for two years (2024-26) in order to analyze the ecological backlash from a public policy perspective. They particularly rely on the study of agricultural policies at both the French and European levels.

Malo Jan studies conflicts regarding climate policy in Europe and competition between parties on these subjects. He shows, for example, that opposition to ecology results from a combination of the increased salience of climate issues and the transformation of public policies, whose economic costs are increasingly perceived as high; he also demonstrates how these changes have authorized certain parties to mobilize groups recognized as the losers of the ecological transition. With **Emiliano Grossman**, he created the index "Executive Climate Change Attention", which measures the presence of climate change in the annual speeches of governments from around the world at the United Nations General Assembly.

On another level, **Zsofia Barta**'s research shows that key actors in financial markets, such as credit rating agencies, explicitly choose to ignore climate risks that are insufficiently quantifiable (climate events being uncertain and their economic impact unpredictable). Consequently, not only do they fail to warn market participants against risky investments in assets vulnerable to climate change, but they also lead markets to undervalue investments in climate protection and resilience.

CITIES AND ADAPTATION TO CLIMATE CHANGE

In her thesis, **Marta Tramezzani** analyses the way in which energy communities (coalitions of citizens, public and private actors, and civil society organizations) interact with municipal public action regarding the energy transition in Paris, Barcelona and Milan.

Charlotte Halpern and **Roberto Rodriguez** (associate researcher) compare the emergence of adaptation policies in Lyon and Paris over the last 15 years. In both cases, adaptation has been seen as a new opportunity to challenge state authority – for example, in areas such as risk and water management and by claiming ownership of new areas of public action, such as vegetalization.

Through the [JET Cities](#) project, **Charlotte Halpern** and **Roberto Rodriguez** also study how cities utilize economic development to promote green jobs in support of the ecological transition.

Cassandre Rey-Thibault, a post-doctoral fellow and recipient of the Latour Fund (2023–26), studies [the adaptation of port cities to the risks of climate change](#) by comparing Boston, Le Havre and Rotterdam, scrutinizing the porosity between the notions of risk management and crisis management. Furthermore, she is involved in a national research programme for integrated risk management (PEPR Risques) regarding NaTech risks (the sequencing of natural and industrial hazards and their cascading consequences).

WHAT ROLE FOR THE STATE IN THE ANTHROPOCENE?

Several research projects focus on environmental policies at different scales, both European and national.

Mathieu Sarnin has recently started a PhD thesis examining the policy instruments developed in France aimed at steering the ecological transition, with the broader aim of understanding the gaps between goals, the planning process, and implementation results.

Charlotte Halpern and **Meryem Bezzaz** study the way in which the public policy sector incorporates environmental assessment.

Richard Balme continues his reflection on the State in the Anthropocene, drawing on the duality of the Chinese State, which is both a leader in investment and technology for renewable energy while remaining the primary importer and a major producer of fossil fuels. In her thesis, **Meryem Bezzaz** studies how the energy trilemma (balancing security of supply, equity and environmental objectives) frames energy policies within the European institutions.

Charlotte Halpern's research has focused on the genesis of the European directive on sustainable consumption.

The European project [ReHousIn](#) (Horizon Europe, 2024–27) to which **Marco Cremaschi** (PI), **Tommaso Vitale**, **Antoine Guironnet** and **Federica Rotondo** contribute, analyzes the effects of transition policies on housing inequalities through a major European comparison involving nine countries. [Preliminary findings](#) show how environmental policy can sometimes unintentionally drive displacement, green gentrification and increased housing inequalities while providing policy recommendations to counteract these negative outcomes.

Jean-Baptiste Bonnet works on the transition of the European automotive industry towards electric vehicles. His thesis compares Germany and France to understand the role of states, as well as political and economic actors, in the pace and form that these transitions take.

Tom Chevalier, **Matteo Mandelli** and **Bruno Palier** are developing research on new social risks linked to environmental transitions, within the framework of the initiative [Social-ecological transition](#), which they co-lead with Eloi Laurent and Anne-Laure Beaussier. Within this framework, they categorize and compare policies designed to combat these social risks across various European countries.



EVOLVING STATES AND PUBLIC POLICIES

Several projects examine the policies developed in European countries that contribute to the transformation of States, which are increasingly perceived through their role as Welfare States.

STATE TRANSFORMATIONS

Philippe Bezes and **Patrick Le Galès** are jointly extending the theory of the *Policy State* (Orren & Skowronek, 2017), according to which the accumulation of public policies constitutes a factor in the destabilization and transformation of institutions and the State. They are preparing a special issue of the *Revue française de science politique* on 'regimes of interdependence between public policies.

Patrick Le Galès has also worked with **Francesco Findeisen** (associate researcher) on the effects of the interaction between policy accumulation and decentralization, which is increasing inequalities between territories.

Philippe Bezes, alongside **Yuma Ando** and others, has updated a database for the 2015–2025 period regarding the organizational transformations of State administrations in France and Europe (originally initiated within the framework of the SOG-PRO project). This research examines the various forms of managerial activities that have developed within the State in France and Germany since the early 1980s, for example, as well as the influence of New Public Management (NPM) reforms on these activities, and how transformations in the political party landscape affect the content of administrative reforms.

Patrick Le Galès is conducting research on the 'de-Europeanization' of the British State following the implementation of Brexit.

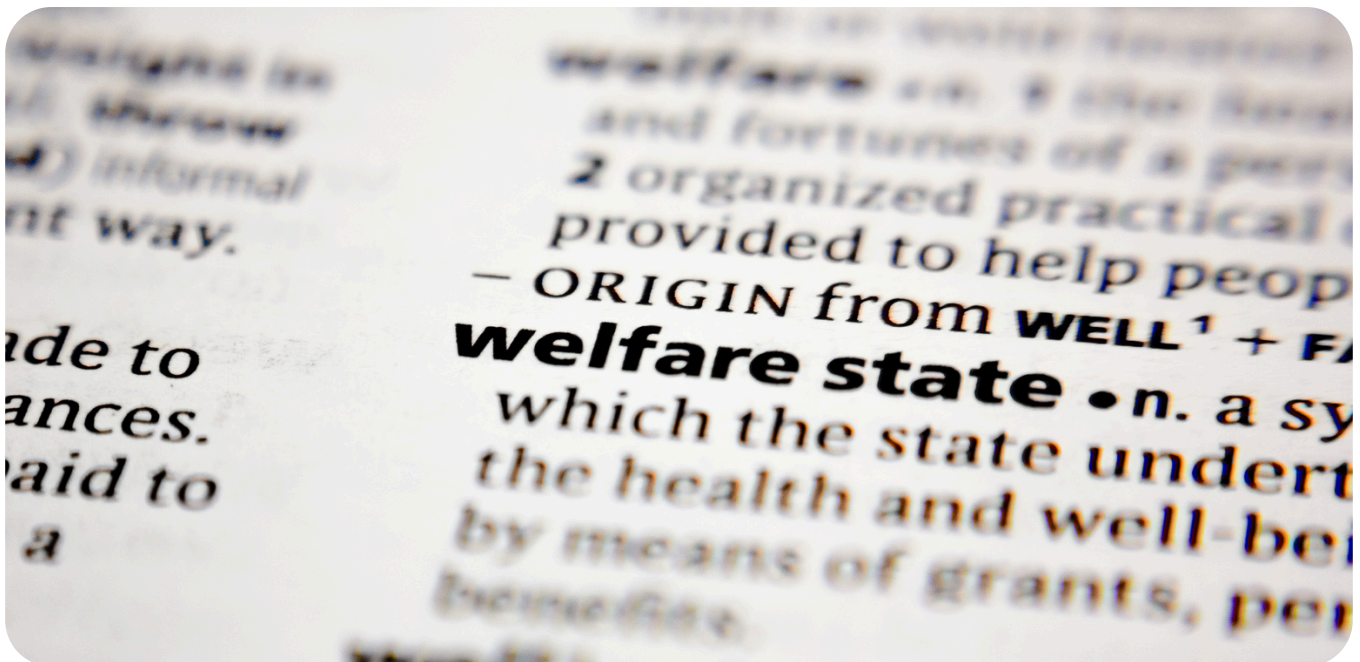
Patrick Le Lidec is developing a socio-historical perspective on the State's governance of territories and the role of these territories in the governance of the State, particularly the role of European integration. He is currently working on an article reviewing Emmanuel Macron's territorial policy and a book on the policy of merging French regions. Furthermore, he analyzes France's administrative reform policies for the European Commission (DG Reform), as part of an annual comparative survey.

SYMBOLIC POLITICS AND POLICY

Following on from *Symbolic Policy* (Cambridge University Press), **Florence Faucher** is continuing her research into the uses of the symbolic in politics and in public policy. She is particularly interested in political rituals (reference to chapter in *What is Politics?* by Colin Hay).

Alongside **Laurie Boussaguet** (EUI), she is working on the political use of the symbolic by the European Union through architecture, awards and the development of European protocol.

Théodore Tallent shows in his PhD thesis how the symbolic dimension of climate policies explains resistance and defiance in rural communities.



QUESTIONING THE WELFARE STATE

Bruno Palier co-edited (with Anke Hassel) *Growth Strategies and Welfare Reforms. How Nations Cope with Economic Transitions* (Oxford University Press), focusing on the interaction between national growth and welfare regimes, government growth strategies, and welfare state reforms in advanced political economies in Europe, the United States, China and Russia. **Bruno Palier** contributed on the French case, while **Cyril Benoît** and **Colin Hay** wrote about the United Kingdom.

Nathalie Morel has published *The Politics of Fiscal Welfare. Towards a Social Division of Welfare and Labour* (Policy Press), which highlights the use of fiscal tools for social protection purposes, specifically tax deductions for personal services in France and Sweden. She traces the political motivations behind this tax advantage and its consequences for dependency care and the labour market.

Nathalie Morel and **Bruno Palier** have also co-edited (with Clément Carbonnier and Michaël Zemmour) *Les politiques publiques par la défiscalisation (Public Policy through Tax Incentives)* (Presses de Sciences Po), which offers a systematic evaluation of the cost and effectiveness of tax loopholes in France.

Ulrike Lepont has been conducting research on health insurance policies in the United States since 2016. She has finalised on the manuscript for a book to be published in 2026, *Le gouvernement des idées. Santé, expertise et démocratie aux États-Unis* (The Government of Ideas: Health, Expertise, and Democracy in the United States) (ENS Editions). On the same theme, **William Genieys** has received several awards for his book *A Government of Insiders* (Johns Hopkins University Press), which traces the difficult reforms of American health insurance coverage policies between the Clinton and Obama presidencies.

Following on from *Que sait-on du travail ?*, **Bruno Palier** has co-edited the volume *Travailler mieux (Working Better)* (PUF/La vie des idées, with Christine Erhel), which provides proposals for improving the quality of work and employment.

Tom Chevalier and **Bruno Palier**, with others, also analyze the adaptation of the Welfare State to a Europe at +4°C (see above).

Tom Chevalier is continuing his work on public policies (social, educational and employment) directed at young people in Europe, focusing on issues of poverty and their relationship with politics.

Finally, the thesis of **Ninon Le Cozannet-Laidin** compares child protection policy in France and Sweden at the national, sub-national and social-worker levels.

ACTORS AND DYNAMICS OF EUROPEAN POLITICAL ECONOMY

Capitalism has entered a new phase: the tertiarization and internationalization of economies, the recomposition of the State's role, and the increased power of financial actors, etc. European economies are thus evolving in a highly dynamic and less predictable context than in the past. Several projects focus on the behaviour of socio-economic and financial actors facing a combination of challenges (inflation, high public debt, austerity and planetary boundaries).

Matthias Thiemann (PI) and **Jérôme Deyris** are interested in the evolution of the role of central banks, within the framework of a Franco-German project (KNOWLEGPO, ANR-DFG, 2023-26). In 2025, they published [a paper on European central bankers' strategic use of economic ideas and data](#). Jérôme Deyris also published a [paper on central bank communication on climate change](#), featuring the largest collection of central bank speeches ever collected.

With the [EvalEU](#) project, **Matthias Thiemann** has also examined public-private (*blended finance*) instruments used by development banks, [with the aim of greening the economy in Europe](#) and China, or for [the reconstruction of Ukraine and its accession to the European Union](#). On the latter subject, he contributes to the "[EU Enlargement Hub](#)" which brings together academics specializing in European integration alongside Ukrainian colleagues.



Cyril Benoît and **Colin Hay** study the political economy of welfare reforms in the context of austerity and high public debt. In particular, they explored [how the UK's asset-based welfare model is being adopted in Europe and other regions](#). **Jan Boguslawski's** [recently defended thesis](#) investigated divergent financialization trajectories across pensions and housing in Poland. **Charlotte Halpern** is involved in a collective project on [post-growth healthcare](#).

Following on from her work [on the concept of the 'Investor State'](#), **Ulrike Lepont** analyzes French industrial policy: aid for start-ups and investment policies in the healthcare industries. Industrial policies were also at the heart of a workshop co-organized by **Matthias Thiemann** in partnership with Columbia University, adopting a comparative perspective between Europe, the USA and China.

Antoine Guironnet published on the [financialization of social and affordable housing in France](#). As part of his doctoral research on macroeconomic policies and housing inflation, **Maxence Dutilleul** conducted fieldwork (interviews and archival research) in France, the USA and the United Kingdom.

Several members of the CEE are examining issues of public debt. **Zsófia Barta**, for instance, focuses on how government bonds are integrated into complex and risky financial products, looking at the way in which fiscal, monetary and regulatory authorities collaborate (or fail to collaborate) to keep government debt markets stable. Her article explains [why credit ratings are entrenched in the financial system and retain their power despite their many well-known faults](#). She also reflects on why the EU cannot rival the United States as a monetary and financial power. **Thomas Laffitte** is continuing his doctoral research on the origins of EU common debt issued to finance the recovery plan during the COVID-19 pandemic, focusing on how the position of Germany has evolved around this issue.

Last but not least, **Colin Hay** is interested in the economic thinking of the current Labour government in the United Kingdom. For her PhD, **Lea Dornacher** is exploring the role of economic models in the policy process, comparing the cases of the minimum wage policy and the Treasury's Green Book in the UK.



Within the [Governing the Urban Dimension of EU Law](#) project (MSCA Postdoctoral Fellowship, 2023-25) **Carlo Colombo** brought law, urban sociology and economics into dialogue to shed light on the implementation of European law in the areas of mobility, air quality and housing in EU cities.

Conflicts of use in European cities are at the heart of two ongoing theses. **Thalia Creac'h**'s work focuses on conflicts over the use and appropriation of space in changing neighbourhoods in Marseille and Liverpool undergoing urban regeneration policies. **Silvia Cesa-Bianchi** is preparing a thesis on overtourism in European cities. In 2025, she focused primarily on the policy instruments adopted by the top 20 European tourist cities during the past decade.

Other cities, other transformations: **Patrick Le Galès** is continuing his research on the French in London after Brexit, as well as his studies on the Paris 2024 Olympic Games and their legacy. Furthermore, he is working on the reformulation and relevance of the 'European city' concept.

Patrick Le Galès is also one of the coordinators of the doctoral network [LAC-EU](#) (MSCA Doctoral Network, 2024–2028), which aims to better understand the Latin America and Caribbean (LAC) region and its relations with the European Union (EU). This project, involving **Eleonora Russo** (coordination, member of the ethics committee), hosts **Luca Venga**, whose thesis focuses on the use of digital participatory democracy tools by public and private actors in local, regional and metropolitan governance in Europe and Latin America. Within this framework, he spent several months in Madrid and Mexico City.

The intersection between cities and digital technology is also at the heart of **Oskar Steiner's** thesis on Artificial Intelligence-based tools for environmental governance in Barcelona, Singapore and Paris – the case on which he conducted his fieldwork in 2025. How does the attempted production of new 'maps' of the urban environment allocate knowledge, authority and legitimacy in urban governance?

Eva Bossuyt tracks the circulation of second-hand clothes donated in Europe between cities on different continents, and the socio-spatial inequalities created by this market. In 2025, she conducted fieldwork in France and Pakistan.

Marcela Alonso Ferreira's [recently defended thesis](#) explains why land regularization has stagnated in recent years in Mexico City while it has expanded in São Paulo, despite similar processes of urbanization, decentralization and democratization.

Rural areas have not been overlooked. In his thesis, **Arno Lizet** studies policies aimed at supporting small rural businesses, seeking to understand the persistence of a specific form of public intervention despite several successive failures.

William Genieys works on [how small wine producers in two French Mediterranean winegrowing regions deal with the issue of adaptation to climate change](#).

Colin Hay has been researching the international wine markets through the responses of [the institution of "la place de Bordeaux"](#) to economic challenges.

COMPARATIVE TERRITORIAL DYNAMICS IN THE EUROPEAN UNION AND BEYOND

CORRUPTION, ORGANIZED CRIME AND JUSTICE

Several CEE projects study illegal and criminal activities that contribute to undermining European democracies. Whether involving corruption, organized crime, sexual violence or mass violence, these issues are approached through the lens of their organizations, their consequences and/or their treatment by the judicial system.

Cyril Benoît (PI) and **Sebastian Thieme** contribute to a European project on political corruption and other forms of undue influence (RESPOND, Horizon Europe, 2024-29). Together with Mihály Fazekas (CEU), they built a large-scale dataset on legislative processes in European countries and beyond. They are now working on a method to measure favouritism in legislation. **Cyril Benoît** also studies the impact of the level of scrutiny given to legislative processes on the economic performance of firms affected by legislative texts.

Gabriel Feltran studies illegal circulations, particularly between South America and Europe. Through the Cocaine Ports project (MILDECA funding, 2024–26), assisted by **Victor Simoni**, he has investigated cocaine trafficking in European ports, including Le Havre. His research sheds light on the evolution of the global cocaine market, demonstrating that it has organized itself according to a platform economy model. He has also co-produced a report on Brazilian criminal factions in French Guiana.

The international organization of crime is also studied by **Federico Varese** (PI) as part of the CRIMGOV project (ERC Advanced Grant, 2021-26), assisted by **Hélène Pautron** and **Francesca De Paris**. The project proposes a new analytical framework distinguishing three types of criminal group activities: production, trade and governance. Federico Varese has also coordinated a special issue of The European Journal of Sociology on this approach. He has continued his work on the Russian and New York mafias.

A Plurality of Methods

While the laboratory has recently emphasized computational methods, it fosters a plurality of approaches and methods – qualitative, quantitative and mixed. The comparative method is a defining feature of the centre's identity and was at the heart of our doctoral study days in 2025.

In 2025, **Sandrine Lefranc** published a collective volume on the trials following the November 2015 attacks in France – the culmination of a study combining trial observations, questionnaires and interviews with professionals and victims. She has continued her research on the judicial handling of sexual violence, the *Cour nationale du droit d'asile* (National Asylum Court) and the prosecution of Rwandan genocide perpetrators seeking refuge in France.

Two ongoing theses also examine judicial responses to mass violence. **Francesco Nardone's** research focus has been on the compensation scheme for victims of terrorism in France. He has investigated the creation of the contemporary compensation regime in the 1980s by doing archival research. **Marie-Inès Harté** explores the mechanisms of transitional justice and peacebuilding following the Colombian armed conflict, as well as the position and role of victims in memorialization initiatives.

Furthermore, **Dominique Boullier** continues his reflections on the relationship between law and digital technology, including the regulation of platforms and the use of AI in the practice of judicial actors.



Public Engagement and Impact

In 2025, members of the CEE actively engaged with various sectors of society to share their research findings and, in several instances, to pursue collaborative initiatives. Several key highlights demonstrate the tangible impact of the CEE's research on wider society.

Impact

These key examples demonstrate the societal impact of the research conducted at the CEE:

- **Federico Varese's** approach to organized crime, which distinguishes between production, trade and governance activities, was adopted in the [2025 World Drug Report](#) published by the United Nations Office on Drugs and Crime (UNODC).
- **Nonna Mayer's** research informed two documentaries in which she also features: *Retour de flamme, 50 ans de normalisation de l'extrême droite* (*Backlash: 50 Years of the Far Right's Normalization*) by Valérie Igounet and Emile Rabaté explores the dynamics of the RN; and *Haine des juifs: ce mal qui déchire la France* (*Hating Jews: The Evil Tearing France Apart*) a "Complément d'enquête" special by Nathalie Sapena, Justine Weyl and Lucie Dulois, which drew on Mayer's data and analysis of antisemitism from the CNCDH (French National Consultative Commission for Human Rights) annual barometer.
- **Pierre Charbonnier's** *L'Écologie de guerre* (*War Ecology*) was cited by [Agnès Pannier-Runacher](#), then Minister for the Ecological Transition, during a high-profile keynote speech.
- **Dominique Boullier's** work, *Propagations*, served as the namesake and inspiration for a [new podcast series](#).
- **Colin Hay** analyses of the challenges to wine markets are used increasingly by professionals in Bordeaux as well as internationally.

Parliamentary Evidence Sessions

Researchers from the CEE are regularly invited to give evidence before the National Assembly, the Senate, the CESE (Economic, Social and Environmental Council) and their international counterparts.

In 2025, notably,

- **Tom Chevalier** provided expert testimony to Senator Antoinette Guhl regarding the proposal to extend the RSA (Active Solidarity Income) to those under the age of 25.
- **Patrick Le Lidec** gave evidence to the Senate Delegation for Local Authorities and Decentralization on the shifting funding models and fiscal autonomy of local government.
- **Nonna Mayer** was called to the National Assembly to testify at the Assises de l'antisémitisme (National Forum on Antisemitism).
- **Bruno Palier** gave evidence to the [National Assembly's Commission of Inquiry into healthcare system organization and access to care](#); he also took part in an exploratory hearing on the theme of "Better Working" for the CESE Labour and Employment Commission.
- **Tommaso Vitale** provided expert testimony on poverty and housing to the Senate Delegation for Local Authorities and Decentralization, as well as the National Assembly's Commission for Sustainable Development and Regional Planning. Internationally, he advised the European Commission's "Climate-Neutral and Smart Cities" mission and the Italian Senate. He also presented his work on associations in Italian cities [at the Italian National Council for Economics and Labour \(CNEL\)](#).

Engagement with Public Officials

CEE members are frequently consulted by public authorities, both in France and internationally. The Centre also establishes formal collaborative agreements with certain institutions.

In France

Pierre Charbonnier presented his work *La Coalition climat (The Climate Coalition)* with *France Stratégie* and the General Secretariat for Ecological Planning.

As part of the Cocaine Ports project, **Gabriel Feltran** organized a series of seminars titled "Offre de stupéfiants et mondes urbains" (Drug Supply and Urban Worlds) in partnership with MILDECA (the Interministerial Mission for Combating Drugs and Addictive Behaviour) and the Sciences Po Urban School aimed at strengthening the link between research and public policy. He also co-authored a report on French Guiana for the Department of Overseas Prison Services.

Charlotte Halpern was consulted by the General Commission for Sustainable Development (CGDD) on issues regarding employment and the ecological transition.

Colin Hay and **Bruno Palier** gave evidence to the High Commission for Strategy and Planning on "Dynamics and control of social expenditures: European comparisons."

Nathalie Morel presented her research on public support for domestic services to the Directorate General for Enterprise (Ministry of the Economy).

Bruno Palier presented the collective work *Les politiques publiques par la défiscalisation (Public Policy through Tax Exemptions)* at the Court of Auditors.

Gabriel Feltran signed a formal agreement with the National Directorate of the Judicial Police to collaborate on homicide data. **Sandrine Lefranc** and **Francesco Nardone** have been negotiating for a data-sharing partnership with the funds for victims of terrorism, to analyze the current compensation practices.

Furthermore, several members of the CEE sit on the scientific boards of various institutions: for instance, **Charlotte Halpern** is a member of the scientific boards of Ademe (The French Agency for Ecological Transition), Ifremer (The French Research Institute for Exploitation of the Sea) and Ihedate (The Institute for Advanced Studies in Territory Management and Development in Europe); **Tom Chevalier** sits on that of the CNLE (National Council for Policies to Combat Poverty and Social Exclusion); **Dominique Boullier** is a member of the Scientific Council for Digital Affairs at the Directorate General of Public Finances (Ministry of Finance); and **Cyril Benoît** is a member of the scientific board of the Observatory of Breaches of Integrity at the French Anti-Corruption Association.

European and International Institutions

Florence Faucher, Emiliano Grossman, Jan Rovny and **Ronja Szczepanski** were consulted by the European Commission Representation in France regarding the EU's strategic communication within the country.

Matthias Thiemann, as part of the EU Enlargement Hub contributed to the conference "Making Enlargement a Win-Win Process" co-organized by the Danish Presidency of the Council of the European Union.

Paula Hoffmeyer-Zlotnik spoke at the Cypriot Pre-Presidency Conference "Reshaping Europe in an age of uncertainty" organized by TEPSA and wrote a recommendation on "Managing migration without feeding the narrative of failure".

For the European Commission, **Patrick Le Lidec** produces an annual report on French administration as part of European Public Administration Country Reports series.

Gabriel Feltran presented his research to the European Union Drugs Agency (EUDA) and to customs services across South-East Europe and the Balkans.

Charlotte Halpern took part in an official UNFCCC side event at COP30 Belém, "Burden by Degrees: From Health Impact Data to Climate Justice & Action".

Dialogue with the Socio-economic World and Civil Society

The researchers of the CEE engage regularly with professionals across the socio-economic sectors in which they specialize.

The CEE co-organized two major events designed to bridge the gap between academic research and socio-economic stakeholders:

- Joint workshops with the European Trade Union Institute (ETUI) on "Understanding the social challenges of contemporary capitalism," featuring contributions from **Zsófia Barta**, **Pierre Charbonnier** and **Bruno Palier** (co-organizer).
- The *Réseau des acteurs de l'habitat* (Housing Actors Network) Annual Conference on the theme "+4°C: What policies will house the France of tomorrow?", featuring **Marco Cremaschi** as a panelist.



CEE researchers also engage with the sector on an individual basis. For example:

Charlotte Halpern was consulted by The Shift Project and *Alliance Villes Emploi* regarding employment and the ecological transition from a European perspective. **Nonna Mayer** briefed the Franco-German Trade Union Network for the Defence of Democracy (via the Friedrich-Ebert Foundation France) on the dynamics of the Rassemblement National (RN).

While not exhaustive, other notable engagements include briefings and presentations for major corporations such as Accenture and Veolia; professional associations including France Assureurs and Sciences Po Alumni; and NGOs such as Anticor, the Lilian Thuram Foundation, *Les Oubliés de la République* and the French Climate Action Network.

Furthermore, CEE members are actively involved in Executive Education and professional training, notably through the Ihedate (Institute for Advanced Studies in Regional Planning) – co-founded by **Patrick Le Galès**, who serves as a seminar lead – as well as the IHEMI (Advanced Studies of the Ministry of the Interior) and the IHEST (Institute for Advanced Studies in Science and Technology).



Public Engagement and Outreach

CEE researchers participate in a vast number of public-facing conferences and events, too numerous to list in full here.

Throughout 2025, we continued our successful partnership with the Maison de l'Europe de Paris, co-organizing two panel discussions at their premises: *Énergie en Europe: défis écologiques, socio-économiques et géopolitiques* (Energy in Europe: Ecological, Socio-Economic and Geopolitical Challenges, with **Meryem Bezzaz** and **Pierre Charbonnier**) and *Logement et transition écologique en Europe: quelles solutions ?* (Housing and the Ecological Transition in Europe: What are the Solutions? - with **Federica Rotondo**).

Eva Bossuyt and **Charlotte Halpern** co-directed an editorial feature, "*Villes Sobres: Vers quelles transitions urbaines?*" (Frugal Cities: the future of urban transitions?), as part of Sciences Po Library's editorial series.

Colin Hay was invited to be an evaluator of the Penfolds evermore competition for environmentally sensitive viticulture projects.

Engagement with the Arts

Federico Varese is the co-curator of the exhibition "*John Le Carré: Tradecraft*", held at Oxford University's Bodleian Library. As a companion piece, he has edited a book on the work and legacy of Le Carré, of whom he was a friend and collaborator. *Tradecraft: Writers on John Le Carré* gathers contributions by friends, collaborators and scholars.

Marcela Alonso Ferreira and **Eva Bossuyt** contributed original fieldwork photography to an exhibition produced by the *Maison des Arts et de la Création*, as part of the Paris Climate and Nature Week at Sciences Po.

Media Presence and Public Commentary

Researchers at the CEE are regular contributors across all forms of media (over 210 recorded appearances in 2025 – a 25% increase compared to 2024).

This engagement spans major general-interest outlets in France (including *Le Monde*, *Libération*, *Le Parisien*, *La Croix*, *Les Echos*, *Ouest-France*, *L'Express*, *L'Obs*, *Challenges*, *Mediapart* and various Radio France stations, as well as RFI, Arte, France 24, Public Sénat, etc) and international titles, such as *The Guardian*, the BBC, Euronews, *La Repubblica*, *O Globo* and *Nikkei*. Our researchers also contribute to specialized publications, such as *Sciences Humaines*, *La Gazette des Communes*, *Acteurs Publics*, *Reporterre* and *Politico Europe*. They also publish contributions in *The Conversation*, *AOC*, *La Vie des idées* and *Le Grand Continent*, as well as opinion pieces in the press.

CEE research is also widely disseminated through the official channels of the CNRS (such as *CNRS Le Journal*) and Sciences Po (*Conférence* and its various editions).

INTERNATIONAL INFLUENCE



More than fifteen nationalities are represented at the CEE. The Centre's international influence is characterized by the hosting of academics from foreign universities and visits by our members to other universities, participation in international conferences and research projects, and responsibilities within international journals, evaluation committees and networks. More information on [page 52](#).

Research stays

In 2025, the CEE hosted 29 [visiting academics](#) at various stages of their careers for periods ranging from a few weeks to several months. These scholars joined us from European institutions (including the EUI, Hertie School, LSE, ULB, and the Universities of Amsterdam, Lund, and Oxford), North American universities (such as Harvard, Chicago, and Ottawa), Latin America (Colegio de México, Universidad Federal Fluminense) and Japan (Waseda).

Our researchers also undertook around fifteen research visits to foreign universities. For instance, **Matthias Thiemann** was the [2025 Scholar in Residence at the Max Planck Institute for the Study of Societies](#), while **Sandrine Lefranc** is serving as a Visiting Professor at the Universities of Montreal and Ottawa for the 2025–2026 academic year and **Selma Sarenkapa** was awarded a [Swiss Government Excellence Scholarship](#) for a one-year stay at the University of Basel. Several researchers have benefitted from the [OxPo](#) and [CamPo](#) partnerships, conducting research at the University of Oxford (**Marcela Alonso Ferreira**, **Malo Jan**, **Selma Sarenkapa**, **Patrick Le Galès**) and the University of Cambridge (**Lea Dornacher**, **Gabriel Feltran**). Others participated in exchange programmes with the LSE (**Maxence Dutilleul**) and the Centre Marc Bloch (**Luis Sattelmayer**), or the CIVICA Alliance short-term visit programme (**Richard Balme** at the CEU). Finally, **Eva Bossuyt** was hosted by Habib University (Karachi, Pakistan) and **Luca Venga** spent time at the Colegio de México and IE University (Madrid) during their fieldworks in those countries.

Participation in international conferences

Junior and senior academics presented their ongoing research at international conferences. In particular, there was [a strong presence of CEE members at the 15th conference of the European Political Science Association \(EPSA\)](#), in Madrid. Other international conferences attended include the [International Conference of Europeanists](#) organized by the Council for European Studies, the [ISA Forum of Sociology](#), [SASE 2025 Conference](#), the [IPSA World Congress](#), the [ECPR General Conference](#) and [ESPANet annual conference](#), among others.

Members of the Centre are regularly invited as keynote speakers. For example, **Caterina Froio** was invited to give the [2025 Peter Mair Lecture](#) at the Political Studies Association of Ireland annual conference.

International collaborations

The Centre's members are actively involved in several collaborative research projects: Franco-German collaborations ([UNEQUALMAND](#), [KNOWLEGPO](#)), European ([AUTHLIB](#), [OPENMIN](#), [ReHousIn](#), [RESPOND](#)) and international (the [LAC-EU](#) and [EULAS](#) networks regroup institutions of the European Union, Latin America and the Caribbean).

Editorial responsibilities

Researchers at the CEE also hold key editorial positions at leading journals. Notably, **Caterina Froio** serves on the editorial board of the [European Journal of Political Research](#). **Colin Hay** is managing editor of [New Political Economy](#), whose [world ranking](#) is 11 out of 706 in political science & international relations (3rd ranked of the European-edited journals, and also highest ranked "specialist" journal).

RESEARCH DATA: INTERACTIVE VISUALISATIONS

Interactive data visualisation tools provide the possibility to explore research-based data in an intuitive way for researchers, policymakers and citizens. Two project teams, in which **Jan Rovny** is PI, developed online data visualisation tools in order to contribute to accessibility efforts for research data.

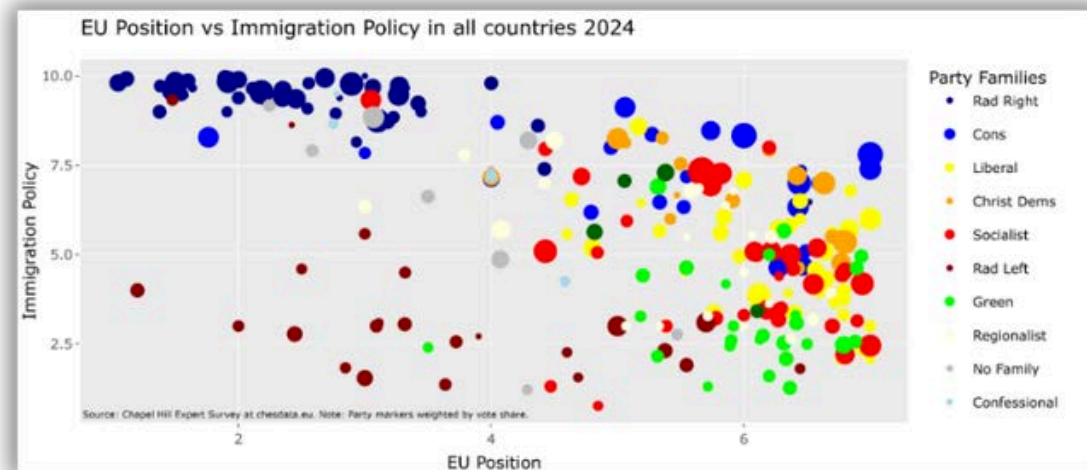
CHES – Chapel Hill Expert Survey

Since 1999, the CHES Europe project has provided expert estimates of European political party positions on major policy issues. These data span various themes such as European integration (e.g., the parties' position on the EU and its policies), ideological divides (e.g., left vs. right, as well as party positions on economic, social and environmental questions) and leading political issues (immigration, economic redistribution, decentralisation, environment, etc.). In 2024, the CHES Europe project examined 279 political parties in 31 European countries.

Interactive Visualisation -

The [Shiny-CHES](#) app allows users to:

- Explore party positions for a given country based on different themes, estimated based on successive waves of polling data.
- Compare countries and political families.

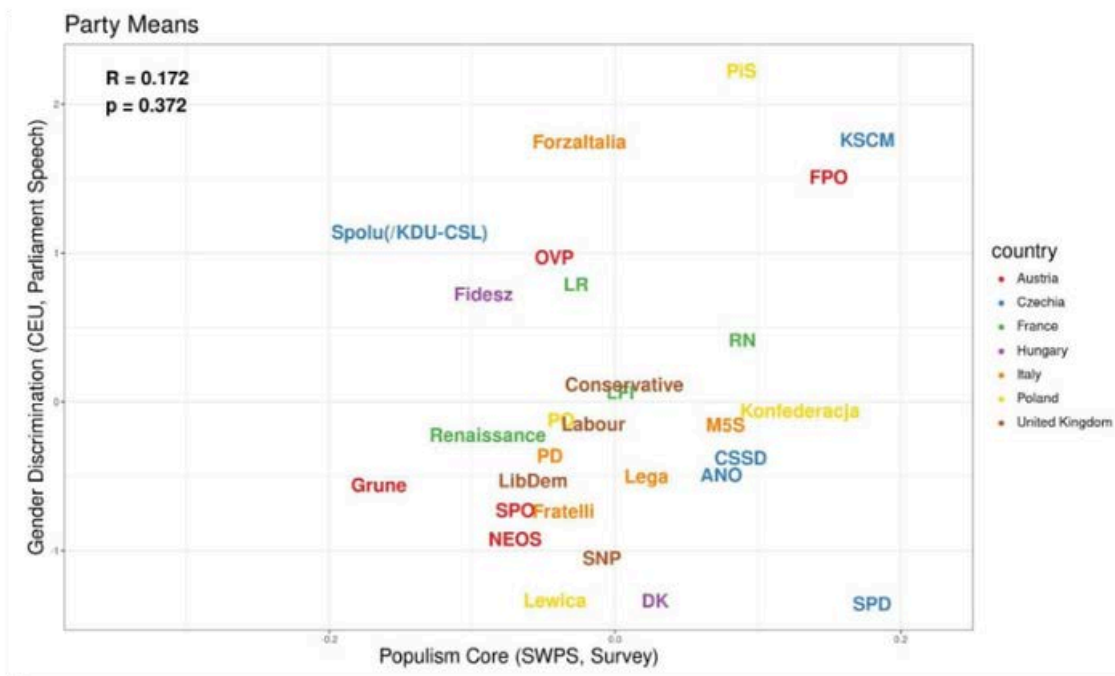
AUTHLIB – Neo-Authoritarianisms in Europe and the Liberal Democratic Response

The AUTHLIB project analyses ideological challenges facing democratic liberalism in Europe by combining multiple methodological approaches in order to measure the emergence of authoritarian tendencies. The project relies on a data series that combines various sources such as surveys, speeches and social media playing out on many levels: citizens, political parties and political leaders. Seven countries (Austria, Czech Republic, France, Hungary, Italy, Poland and the United Kingdom) are covered from 1999 to 2024.

- Countries', political parties' and political leaders' scores based on ideological positions such as illiberalism, populism, nationalism, etc.
- Relationships between different ideological positions.

Towards a Social Division of Welfare and Labour

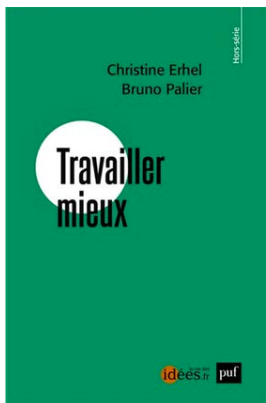
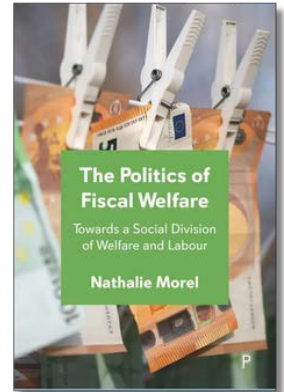

Fiscal welfare (or social tax expenditures) is a policy instrument associated with Liberal welfare states that has been on the rise across many European welfare states.

This book sheds light on the use and effects of fiscal welfare in France and Sweden. Focusing on the introduction of a 50% tax deduction on domiciliary care and household services, it explores the politics behind this scheme, its effects on care provision as well as on labour market dualisation,

highlighting how fiscal welfare contributes to structuring both a social division of welfare and a social division of labour.

This ground-breaking book opens a new field of research by exploring fiscal welfare, the political uses of this policy instrument, the patterns of inequalities it gives rise to and its policy feedback effects.

UN VERDICT SANS APPEL

Enquête sur le procès des attentats de novembre 2015

Pendant cent quarante-huit jours, quatre chercheurs ont assisté au procès des attentats de novembre 2015 commis à Paris et à Saint-Denis. Le 29 juin 2022, vingt hommes ont été déclarés coupables ; 2 318 femmes et hommes ont ensuite été confirmés dans leur statut juridique de victimes. Le verdict n'a pas été contesté.

Ce livre propose une lecture inédite du déroulement de l'audience et déconstruit l'évidence du récit judiciaire. Le procès a été présenté comme le jugement exemplaire de "monstres imprégnés de religion" et devenus des "machines à tuer". Or ce qui a été dit à la barre montre que le terrorisme se nourrit de bien d'autres choses.

Le procès a été considéré comme une réparation offerte aux victimes et à la Nation. Or les victimes ont surtout été invitées à exposer leurs traumatismes. Certaines d'entre elles ont du reste pointé les manquements de l'État français – mauvais protecteur des vivants, gardien brutal des morts, éducateur défaillant des "jeunes de banlieue", ou acteur imprudent sur la scène internationale.

Le procès a-t-il permis d'éclairer le processus qui a conduit aux attentats ? Comment les avocats et les magistrats ont-ils pondéré droit et politique pénale antiterroriste ? Les sciences sociales proposent ici d'ouvrir le débat.





LA COALITION CLIMAT

Travail, planète et politique au XXI^e siècle

En dépit du consensus scientifique sur l'urgence à agir, de l'activisme associatif et de la mobilisation internationale, les politiques climatiques tardent dangereusement à se mettre en place. La société paraît même plus divisée que jamais et la cause du climat ne rassemble pas.

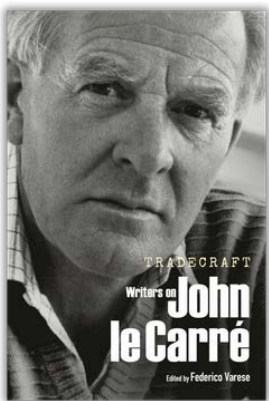

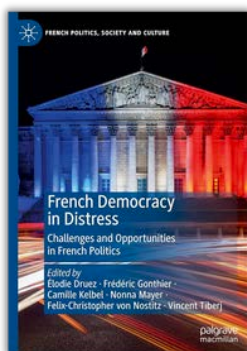
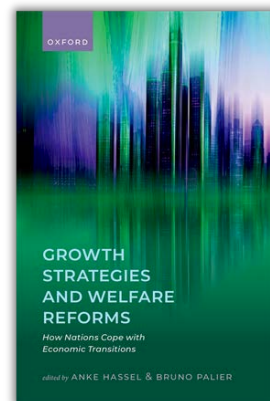

This book seeks to answer these questions by exploring the economic and social trajectories of advanced political economies in Europe, the United States, China, and Russia in the twenty-first century.

It focuses on the interaction between national growth and welfare regimes, government growth strategies, and welfare state reforms to explain these countries' differing developments from the 1990s to the mid 2020s. The chapters offer theoretical, typological, and empirical comparisons between advanced capitalist countries, alongside detailed national case studies, in order to further understand their general economic and social features and their developments.

Growth Strategies and Welfare Reforms features contributions from leading scholars in comparative political economy and comparative welfare state research, and presents a sophisticated theoretical approach, drawing on but also moving beyond varieties of capitalism and growth model approaches.

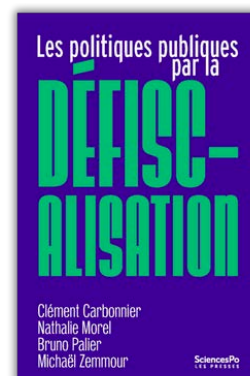

Les dépenses fiscales (communément appelées « niches fiscales ») regroupent l'ensemble des avantages fiscaux et réductions d'impôt prévus par la loi afin soit d'augmenter le revenu de certains ménages, soit d'inciter les acteurs économiques à développer leur activité dans certains secteurs. Ces politiques de défiscalisation sont peu à peu devenues un instrument majeur des politiques publiques en France.

Alors que les déséquilibres budgétaires font l'objet d'une attention accrue, les auteurs de cet ouvrage proposent une évaluation systématique du coût et de l'efficacité de l'ensemble de ces dispositifs. Ils mettent au jour les mécanismes communs qui les caractérisent: des coûts mal maîtrisés – souvent supérieurs à ce qu'aurait représenté un financement direct –, un fort niveau d'inefficacité par rapport aux objectifs annoncés dans de nombreux cas, un accroissement des inégalités, ou encore la difficulté à revenir en arrière.



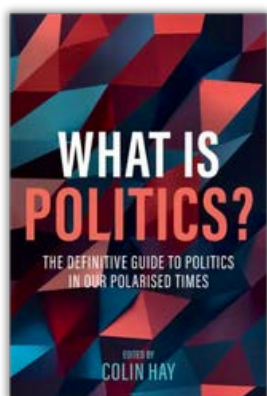
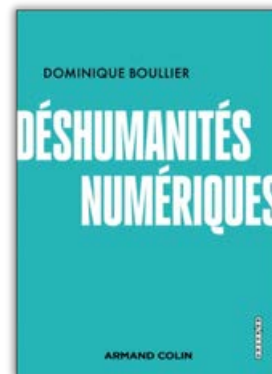
DÉSHUMANITÉS NUMÉRIQUES

Que faire ? Qui croire ? Se déconnecter ? Changer de réseau social ? Interdire TikTok ? Laisser nos enfants devant les écrans ou les protéger ? Apprendre à utiliser l'IA, et laquelle ? Écouter les prophètes de malheur ou les vendeurs de miracles ? Choisir les standards des plateformes ou les solutions indépendantes et libres ? Se méfier de la Russie, de la Chine, des États-Unis ? Ou croire en l'Europe ? Suivre les aventures des héros de la Tech ?

La désorientation est générale pour le public, pour les décideurs comme pour les chercheurs tant la rapidité des changements techniques, économiques et politiques est fulgurante et surtout incertaine.

L'irruption de l'IA générative en 2022 en fut la marque la plus brutale, mais les dérives des réseaux sociaux comme l'ingérence de ces plateformes dans les élections et les attaques informatiques font partie de ce chaos généralisé dans le numérique. Des réseaux et des technologies qui n'ont jamais vraiment été gouvernés amplifient les clivages et les risques sociaux. ABOVE AND BEYOND RESEARCH

Equality, diversity and inclusion: commitments in action



The CEE has strengthened its commitment to equality, diversity and inclusion, notably driven by the *Les Chouettes* (The Owls - “*chouette*” also means great in french) working group. This inclusive collective, which originally brought together women from the Centre across all staff categories, has also organized mixed-gender meetings. Adopting an approach that is both reflective and operational, it aims to create spaces for mutual support while helping to identify and reduce imbalances – particularly gender-based – through a lens attentive to intersectional dynamics. Beyond its work on gender equality, the group has expanded this year to address broader issues of diversity and inclusion, in coordination with the initiatives led by Sciences Po’s Direction of Engagement.

In 2025, *Les Chouettes* initiated a series of collective actions designed to foster a more inclusive working environment. These included training workshops led by the consultancy firm *Équilibres* covering topics such as limiting beliefs, self-assertion, work-life balance and collective intelligence tools. *Les Chouettes* also proposed and facilitated a World Café workshop during the laboratory’s internal away day, focusing on issues related to quality of life at work. These initiatives were based on periods of discussion and a survey that highlighted specific problems within the laboratory, such as the distribution of speaking time and collective tasks. By promoting the co-construction of solutions and encouraging cooperative dynamics, the group contributes to a progressive transformation of professional practices and the collective working environment within the CEE.

A permanent exhibition at the heart of laboratory life



In 2025, the Centre launched a project aiming to go beyond a simple refurbishment of its workspaces, by seeking to establish a visual identity that reflects the richness and diversity of its scientific activities. Designed as a collective endeavour, this initiative relied on a broad consultation with members of the laboratory, who were invited to share their suggestions and proposals. This participatory process fostered a shared vision while reinforcing collective momentum around a unifying project.

The final selection brings together a body of photographs and illustrations reflecting the plurality of research conducted at the CEE, as well as the core themes that define its scientific identity: Europe, democratic transformations, environmental challenges and the diverse subjects of study pursued by our members.

Particular attention was paid to contributions from the Centre's own members. Several photographs – taken during fieldwork, travels or engagements within European political and institutional spaces – provide the initiative with an embodied character.

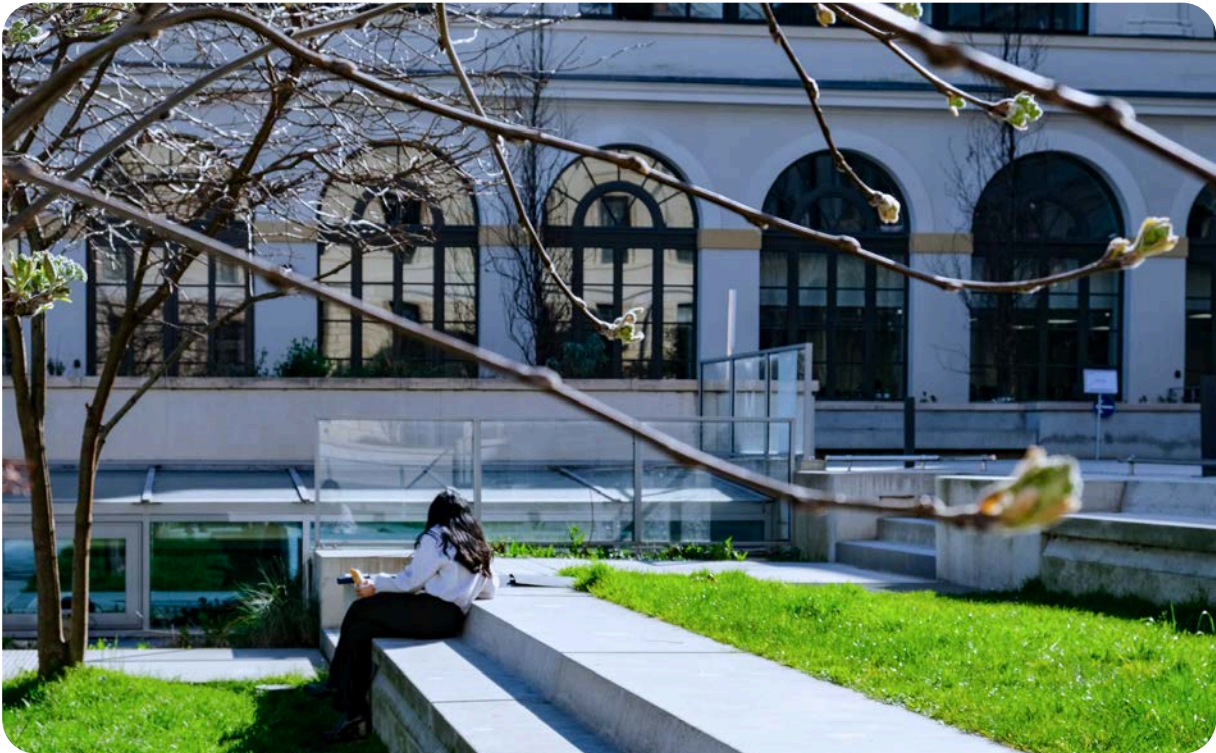
