## ■ Presentation of the CRIS Research Centre

The Center for Research on social Inequalities (CRIS) is a research unit at Sciences Po in Paris and of the CNRS - InSHS (Joint Research Unit UMR 7049). Its members are attached to the Department of Sociology and to the Department of Economics at Sciences Po for their teaching.

They may be affiliated with other research centers or programs such as LIEPP, Presage, MiDi, AxPo, Aire, or Cities are back in Town.

The CRIS (formerly the “Sociological Observatory of Social Change – OSC” until 2022) has been developing cutting-edge research on social stratification and inequalities since 1988. Its research program pursues 3 main objectives:

- Measure and compare the evolution of social inequalities in France and in contemporary societies
- Analyze the mechanisms of social inequalities at the micro- and macro-levels
- Contribute to the analysis of public policies.

CRIS researchers are internationally recognized for their expertise in the study of social inequalities. Their work covers a wide variety of research fields: gender, origin, social environment, education, urban segregation, family, the role of the state and its policies, social habits, mobility and migration, cultural practices, digital uses, the environment, crime and policing, socio-economic segregation, and the labor market.

Being anchored in empirical sociology, interdisciplinary openness, theoretical and methodological rigor, and respect for the autonomy of researchers constitute the pillars of CRIS’ research approach. The results of CRIS research are published in leading peer-reviewed journals in the discipline, both in France and internationally. CRIS members present their research at international conferences and regularly contribute to fueling public debate.

As a host research laboratory for Sciences Po’s doctoral program in sociology, CRIS is distinguished by its commitment to high-quality doctoral training that has an international and interdisciplinary approach, focusing on the latest theoretical and methodological developments related to the study of social inequalities.

The working language at CRIS is English for most scientific events and meetings.

Carlo Barone has been the director of the Center since September 1st, 2024.

# ■ Your integration at CRIS

CRIS doctoral candidates are monitored as follows:

## 1. CRIS commitments

CRIS doctoral candidates are expected to actively participate in the academic life of the centre:

- ◊ They are invited to all scientific events, while they also contribute to the elaboration of the CRIS annual seminar program;
- ◊ They receive all relevant CRIS information and announcements;
- ◊ They are involved in collective research projects, with a view to their involvement in the life of the Center and their professionalization;
- ◊ They occupy a shared office space within the CRIS location in Sciences Po's main campus building at 1 Place Saint Thomas d'Aquin, wing B, 2nd floor), as well as logistical facilities (photocopier/scanner/printer, business cards, letterhead, etc.);
- ◊ CRIS supports as much as possible its PhD student efforts to execute and promote their research work;
- ◊ CRIS involves doctoral candidates in its range of activities, giving them the opportunity to acquire broad skills that will enable them to integrate more effectively into their careers, both inside and outside academia: training, teaching and/or tutoring, participation in conferences, promotion of their research and publishing personal pages on the Center's website.

## 2. Doctoral students' commitments

Doctoral students must respect the French ministerial obligation to complete their thesis in 6 years.

They are expected to attend and participate in the weekly CRIS seminar and the monthly doctoral workshop, General Assemblies, as well as all of the Center's academic events.

Note: Attendance at the weekly seminar is not optional for PhD candidates, but is required. If you need to miss a seminar, please inform your PhD supervisor as well as research coordinator Allison Rovny ahead of time.

In addition, CRIS PhD candidates agree to present their research as part of the Centre's activities (in the doctoral workshop and/or weekly seminar) and to keep the research support team informed of their activities (teaching, travel, fieldwork, presentation of their work at conferences, etc.). Like all researchers, they are bound to respect the rules of research ethics and academic integrity.

## 3. Doctoral supervisor

At least one permanent member of the CRIS research team, assisted by the research coordinator, coordinates the supervision of doctoral candidates.

## 4. CRIS funding for doctoral candidates

CRIS devotes part of its budget to funding which is specifically reserved for doctoral candidates.

These funds are subsidiary to those of Sciences Po's School of Research, which must be requested before applying to the Center. The members of the Laboratory Council decide on the requests.

All research-related travel, whether financed or not, must be preceded by a request for an "ordre de mission" and signed by the doctoral candidate, thesis Director and CRIS Director (or General Secretary):

## **5. Representation of doctoral candidates**

Doctoral candidates elect the persons (titular and deputy) they wish to propose to the CRIS Director to represent them on the Laboratory Council, by secret ballot.

## **6. Individual doctoral candidate monitoring committee**

The "*Comité de suivi individuel de thèse*" is governed by a decision of the ED234 Board (March 23, 2022).

This subject is discussed regularly at the Research School's Executive Board, which is considering changes (within the framework defined by the French Ministry of Higher Education and Research).

While CRIS's role here is to help ensure that these individual monitoring committees are organized, it is up to the doctoral candidate and her/his PhD supervisor to decide on the committee composition. It is recommended to include at least one committee member from outside CRIS. The PhD thesis supervisor is not a member of the monitoring committee.

In the event of difficulty, the doctoral candidate is invited not only to discuss the matter at meetings with his or her monitoring committee (who can be contacted at any time during the year), but also to contact the CRIS direction, which will initiate mediation (in conjunction with the EDR, the EDR mediator, the doctoral candidate faculty advisor and, if necessary, the academic department). The multiplicity of interlocutors enables us to widen the scope of discussion on sensitive subjects.

## **7. Sharing information**

The list of doctoral candidates is made available to doctoral candidate representatives in order to encourage circulation and sharing of information. Furthermore, the Secretary General of the Center supports the doctoral candidates in their exchanges with the various interlocutors of the institution (the department, research school, academic center, etc.)

## **8. Support for the professional integration of doctoral candidates**

CRIS strives to promote the academic and non-academic professional integration of doctoral candidates by the means at its disposal. Our goal is to prepare our doctoral candidates for the international academic market while continuing to guarantee them very good integration in France. The doctoral training role at CRIS is thus distinguished by the weight it gives to internationalization: training in writing research articles and giving paper presentations in English, setting up professionalization workshops, sharing of the international CRIS network (by facilitating participation in international conferences, workshops and events to encourage their networking with international researchers), inter-collaborations, participation in international research projects and interdisciplinary collaborations, thus making it possible to strengthen skills and international visibility, along with its policy of inviting junior and senior visiting scholars (sharing of experiences, academic exchanges), communication about international opportunities and financing of research trips and much more. To encourage international publication (with the possibility of financing linguistic editing).

The CRIS supports doctoral candidates as much as possible after their PhD thesis defense by supporting their efforts to publish their doctoral work and bringing all the information available to them. Recent CRIS PhD graduates also have associated researcher status for two years following the thesis defense.

## ■ Throughout your PhD thesis

Sciences Po's School of Research oversees the administrative follow-up of PhD candidates, from the recruitment stage to the PhD thesis defense, in conjunction with the host laboratory, CRIS.

Two documents are sent for signature as soon as PhD candidates register for the doctoral program:

- **The Doctoral Charter**, which sets out the general framework within which doctoral thesis research takes place at Sciences Po, in accordance with the governmental decree of May 25, 2016,
- **The Training Agreement**, which outlines the support the doctoral candidate will receive throughout her/his training.

Doctoral candidates must give a copy of these two documents to the host research center.

### HAL Sciences Po open archives

It is compulsory for all members including doctoral candidates to create a record of any publication on the HAL Sciences Po portal. This record is used to measure the institution's academic production, and to promote it within the community. The weekly newsletter emails from Research at Sciences Po, for example, are sourced by new HAL records. It is also planned that research center websites will automatically display references entered in the HAL depository.

### Research data

The dissemination of research data and processes has become a key issue in the social sciences. Beyond attaching appendices to journal articles, the practice of publishing code on a GIT or uploading of documented data into a repository is becoming commonplace, with the aim of replicability and re-use.

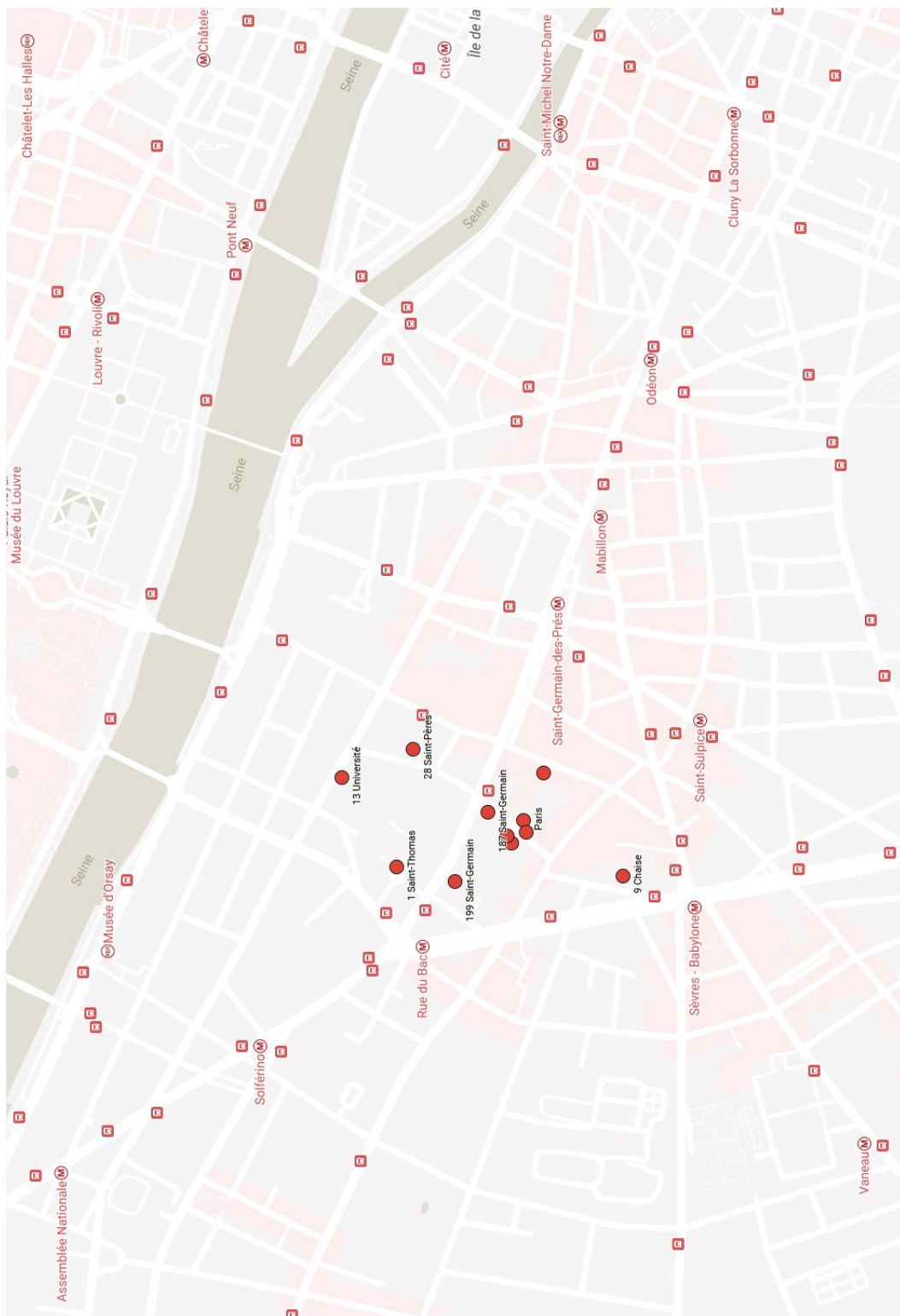
