

DOCUMENT(S) TO BE PROVIDED UPON THE GRANTING OF EXTERNAL FUNDING TO SCIENCES PO (EXCLUDING SCIENCES PO DOCTORAL CONTRACT)

You have been admitted to the doctoral programme subject to the review of the financial conditions for carrying out your research. The Dean of the Doctoral School will assess the conditions of this doctoral funding before 1 September of the current year or before 1 December for CIFRE and COFRA.

Once you have obtained the expected funding¹, you will need to provide the administrative manager of the doctoral programme to which you are attached²² with a certificate from the funding organisation (see page 2) containing the following details related to the funding:

- the start date,
- the duration,
- the frequency (monthly, quarterly, annually),
- the gross monthly amount,
- the obligations attached to the funding; these should not represent more than one day of activity per week (except for CIFRE, where the obligations will be assessed on a case-by-case basis),
- the commitment to respect the academic freedom of the doctoral candidate — including the research content, the thesis, and the composition of the defence jury — as well as the institution's Charters of Ethics, Ethics and Scientific Integrity, and Acceptance of Private Funding.

Special case for full-time employees working on research directly related to their employment: they must obtain, in addition to a proof of income, the employer's agreement to allow them the necessary time to carry out their research (availability of at least two days per week).

IMPORTANT: Funding is only possible if the doctoral candidate's research topic is clearly aligned with the mission and strategy of the financing institution.

¹ *Funding must neither come from personal resources nor from public or private organisations (foundations, associations, companies, public authorities, international organisations, local authorities, or others, subject to prior approval by the Doctoral School) providing doctoral funding.*
