# The LIEPP Environmental policies research group : objectives



- 4 main objectives
  - Examines the role of public policies in the field of environment in the broadest sense.
  - Develop research in the fields of sustainable development, climate change, green growth and, more recently, energy and ecological transitions.
  - Make sense of the transition dynamics at work and to shed light on choices made by policy-makers and actors.
  - Reach out to major public organizations in France, the EU (and beyond)
- **Interdisciplinary approach** – to combine theoretical approaches and investigation methods from social sciences (political science, economics, sociology), natural sciences, and life sciences.
- **Policy evaluation research content and methods**
  - The production of data, expertise and knowledge across multiple levels of governance
  - Diversified toolbox (law, taxation, incentives, etc.);
  - the functioning of multiple organisations (public, private, civil society) that contribute to environmental regulation
  - disjointed temporalities and uncertainties;
  - strong permeability to context effects.
