





# Hypotheses


**Problem Hypothesis:** Grandstanding is more prevalent in problem-focused hearings.

*Legislative Solution Hypothesis*: Grandstanding is even less prevalent in solution-focused hearings involving proposed legislation.


























### Conclusions

Grandstanding in committee hearings happens in a predictable way.

- A bit more grandstanding in problem hearings
- Less grandstanding in solution hearings
- Even less grandstanding in legislative-based solution hearings
- Grandstanding varies by issue
- More opportunities for grandstanding
