**Sébastien Chauvin** is Assistant Professor of Sociology at the University of Amsterdam and a researcher at the Amsterdam Institute for Social Science Research. With the help of ethnography, historical sociology and social theory, he explores areas where different types of social inequality are enacted, reproduced and contested. His main research deals with labour, employment, immigration and citizenship in France and the United States. He is the author of *Les agences de la précarité: journaliers à Chicago* (Le Seuil, 2010) and *On bosse ici, on reste ici! La grève des sans papiers* (with Pierre Barron, Anne Bory, Nicolas Jounin and Lucie Tourette, La Découverte, 2011). With Bruno Cousin he has developed a research program on social capital and the cultural sociology of global economic elites.



**Bruno Cousin** is Assistant Professor of Sociology at the University of Lille 1 and an affiliated researcher at the *Centre Maurice Halbwachs* (ENS/EHESS/CNRS). His research focuses amongst others on urban segregation, upper and upper-middle classes' avoidance and refusal of social or ethnoracial integration. He has published in journals such as *Sociétés Contemporaines*, *Sociologie du travail*, *Sociologie* and *Actes de la recherche en sciences sociales*. The first results of his current fieldwork, conducted with S. Chauvin, on Paris social clubs has been published in *Ethnic and Racial Studies* as "Globalizing forms of elite sociability: varieties of cosmopolitanism in Paris social clubs".



**Patrick Le Galès** is CNRS Research Professor of Sociology and Politics, at Sciences Po Paris, Centre d'études européennes and he chairs the "Cities are back in town" and "restructuring the state" research groups. His research deals amongst others with comparative public policy, policy instruments and the political sociology of the state. He is currently working on the project *What is governed?* in which he compares modes of governance (and urban development in Paris, London, Sao Paulo, Mexico). His latest book is *Globalising minds, roots in the cities, upper middle classes in Europe?* (with Alberta Andreotti and Javier Moreno Fuentes, Wiley/Blackwell, 2015).
