Operative Time of Benefit

The cover under the policy applies whole world exclusively worldwide exclusively during missions carried out by an insured persons on behalf of the FONDATION NATIONALE DES SCIENCES POLITIQUES.

Mission refers to:

- for non-salaried corporate officer, employees, salaried, policy officer: business trips on behalf of the FONDATION NATIONALE DES SCIENCES POLITIQUES and/or IEP de Paris;
- for students: study stays carried out within the scope of training provided by IEP de Paris and on behalf of the latter. It is specified that the cover is maintained to students throughout during the their year off with the approval of IEP de Paris.

For all Business Travel / Study Stays, the cover provided by the policy comes into force as soon as the insured person leaves his/her usual place of work or home and ceases on his/her return to the first point of return from these two places.

During this period, cover is acquired 24 hours a day for the duration of the said Business Travel / Study Stays.
